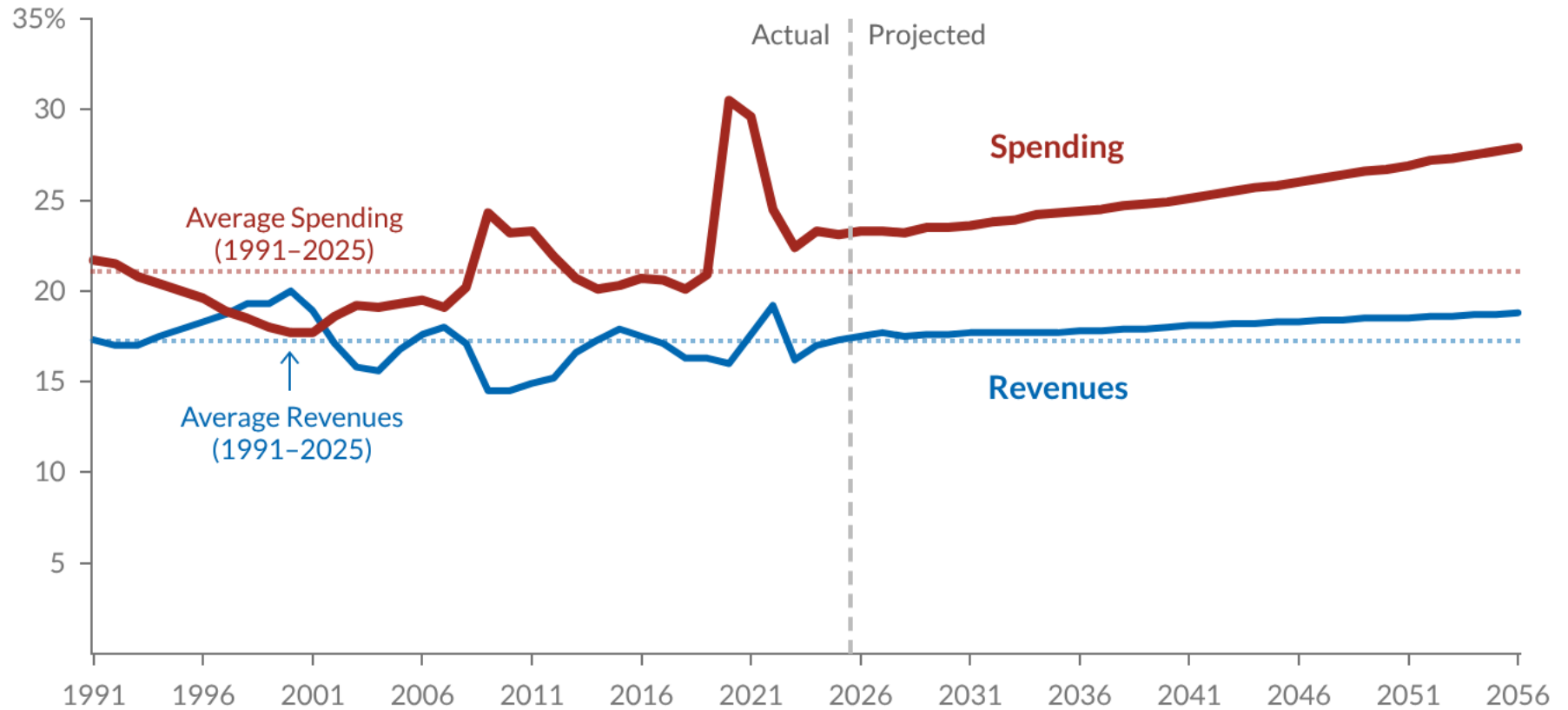

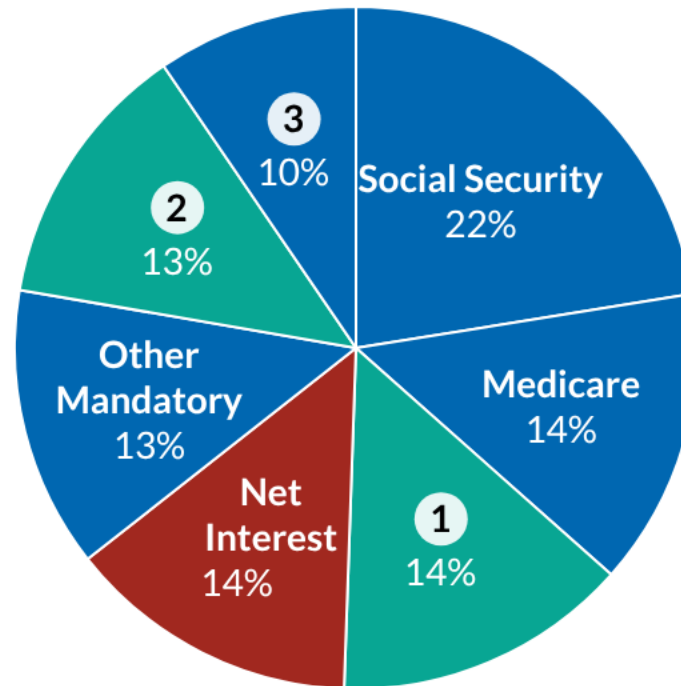

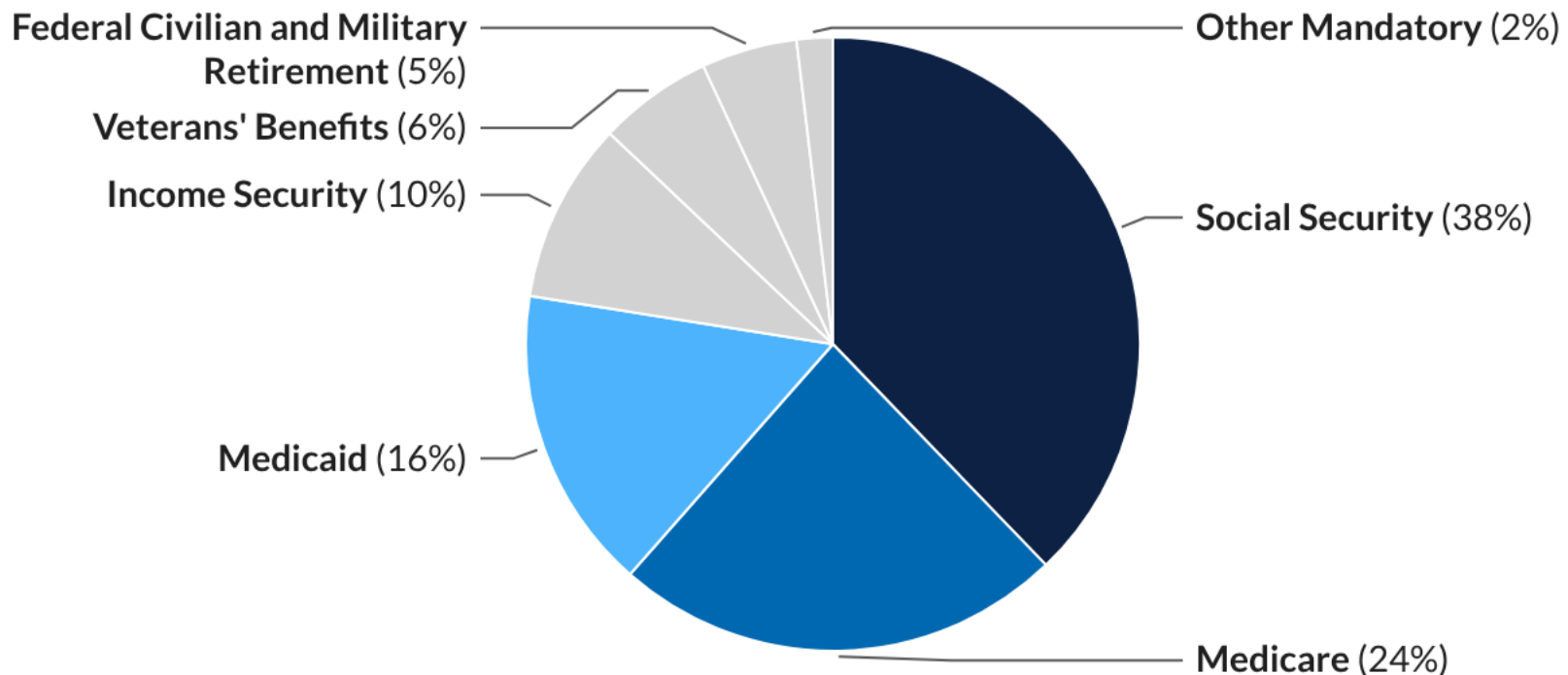

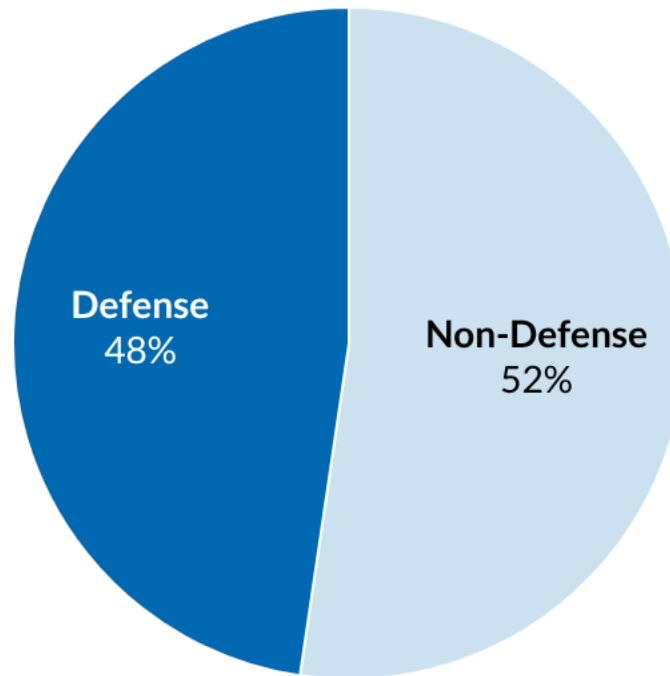

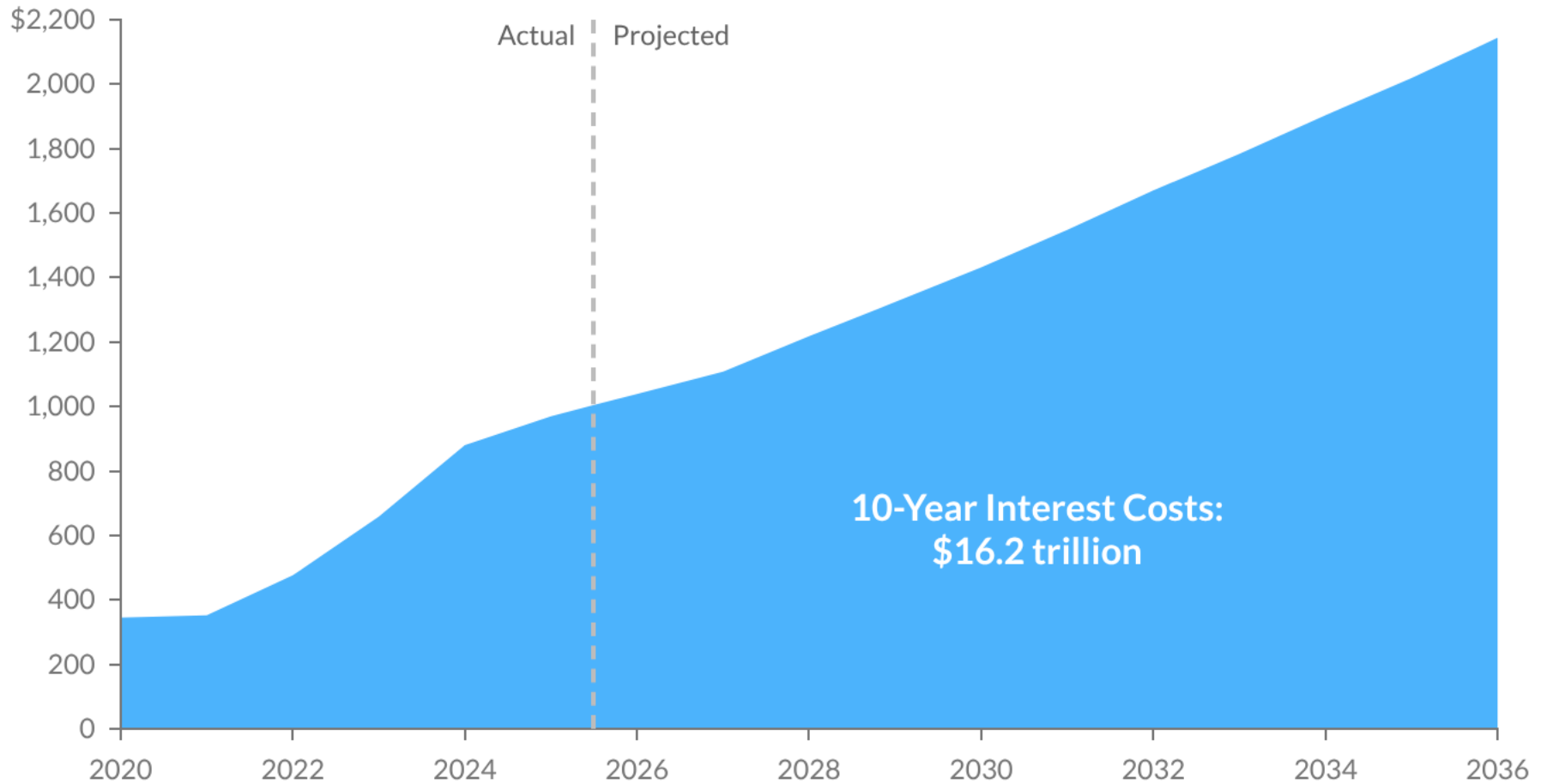

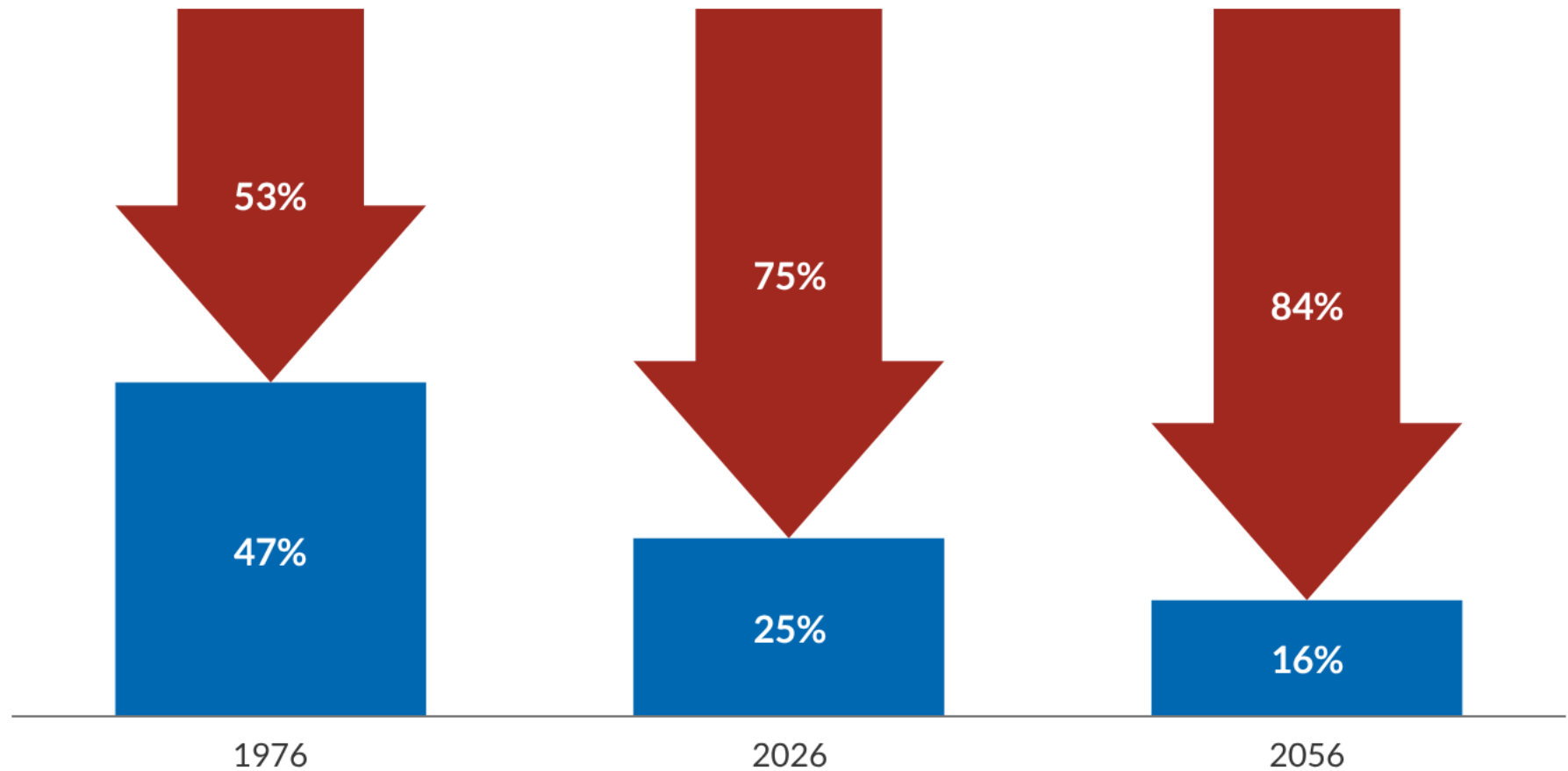

■ Discretionary ■ Mandatory and Net Interest Spending



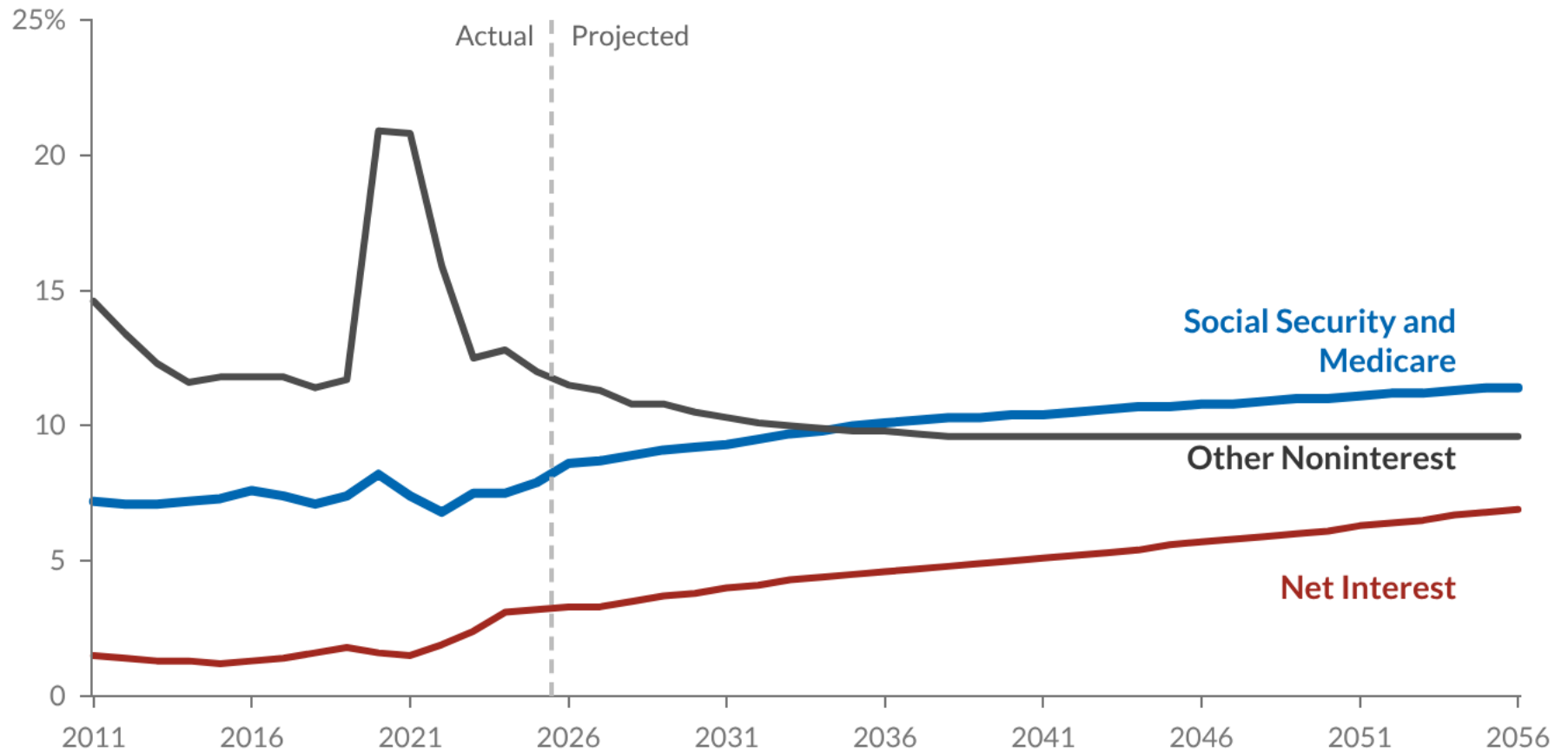

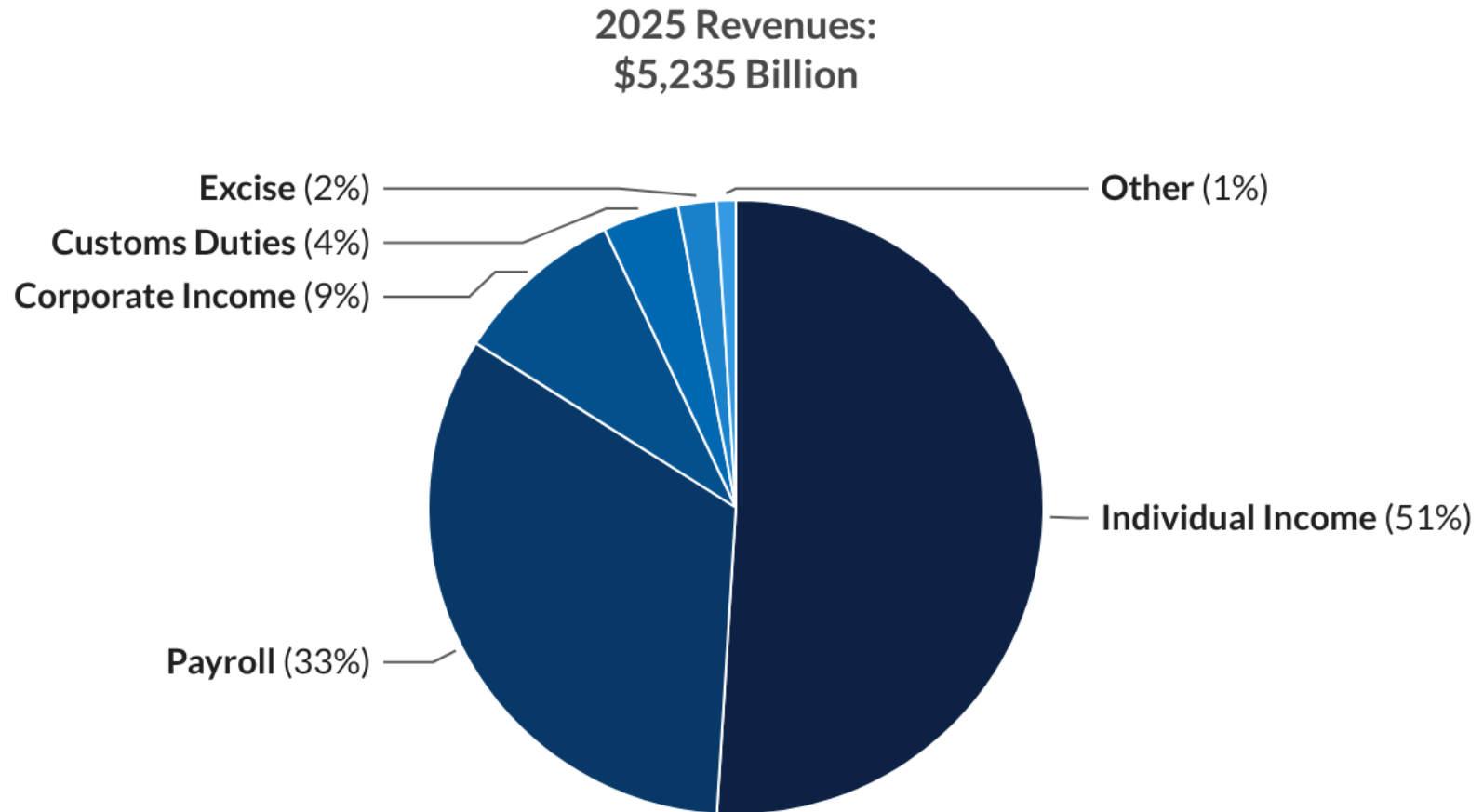

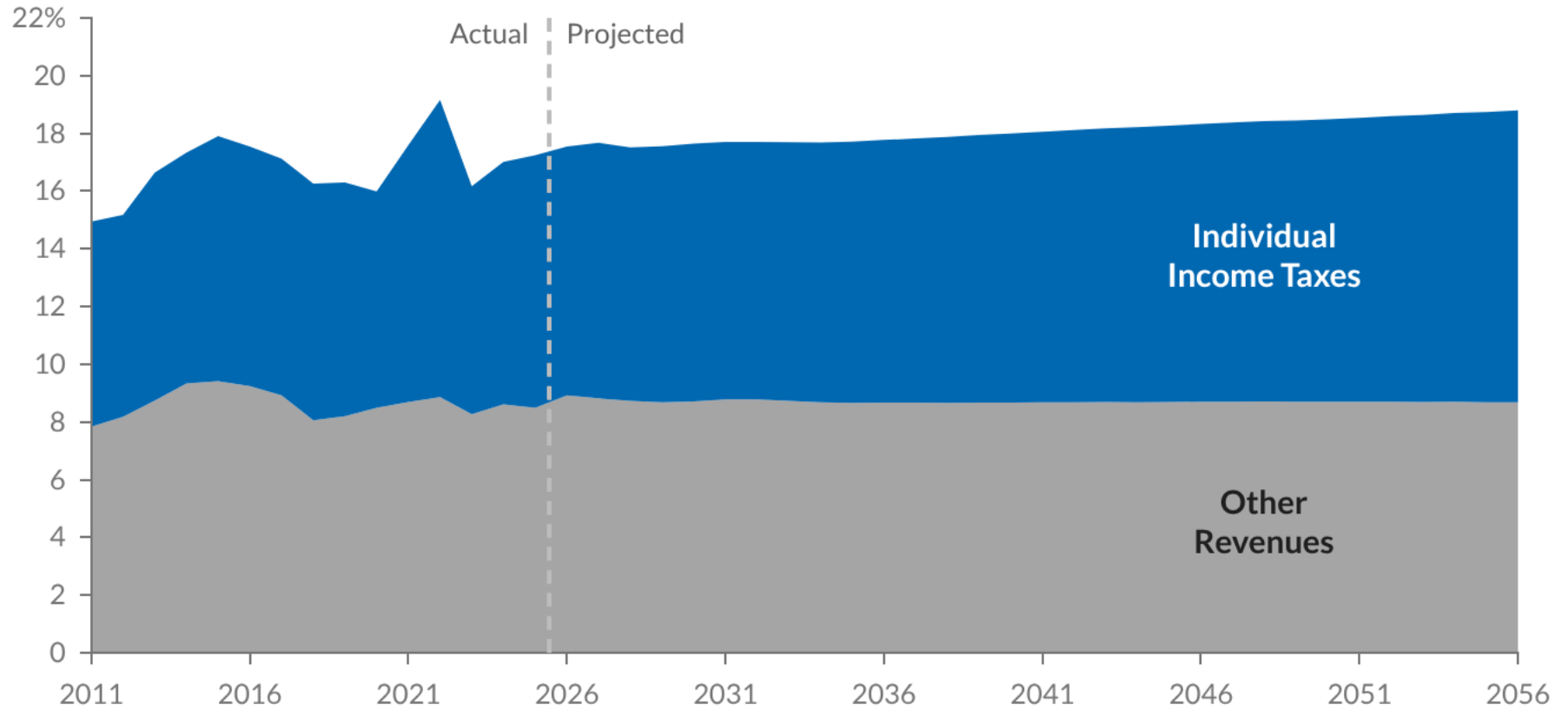

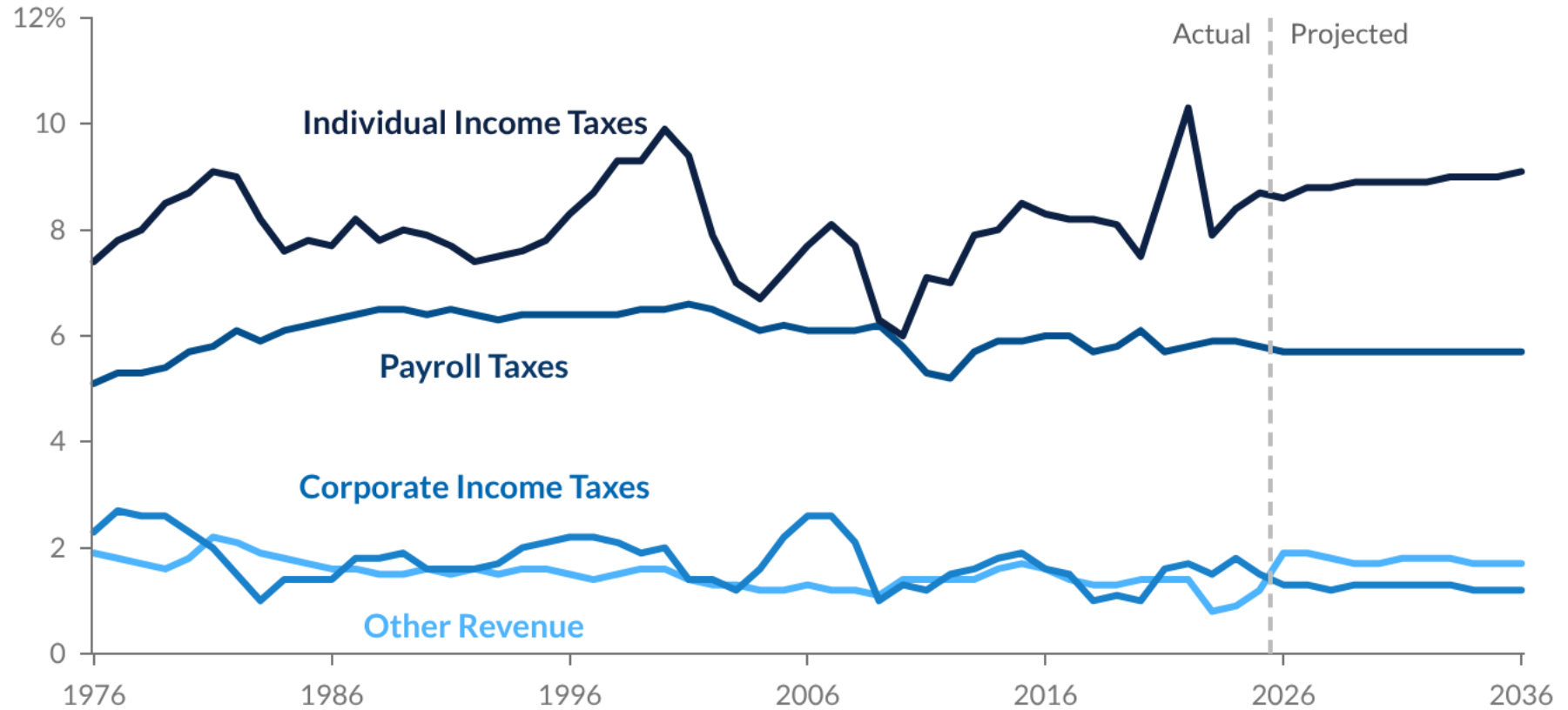
